OFFSETS SUBCOMMITTEE

- To recommend design of offset system as element of WCI program
- Offsets = Emissions reductions from sources (projects) outside scope of cap and trade system
- Design must ensure these are:
 - Real
 - Additional (beyond requirements)
 - Verifiable
 - Permanent
 - Enforceable

- Accounting & transaction structure for all sectors in WCI market-based mechanism
- Consistent with The Climate Registry protocols
- Identify sectors for future protocol development, frame schedule

ELECTRICITY SUBCOMMITTEE(Accounting & Compliance)

- Recommend downstream point of regulation (probably)
- Design market-based compliance mechanism
- Develop accounting structure to cap CO2 emissions from electricity
- Includes electricity imported into WCI partner states/provinces
- Scope subcommittee may add SF6 from electricity T&D, upstream CO2 and CH4 from generator fuel suppliers
