Proposed Alberta Clipper and Southern Lights Pipeline Projects

We are writing to introduce two proposed Enbridge pipeline projects: the Southern Lights and Alberta Clipper Pipeline Projects. As a result of major expansions of the production facilities in Canada's growing oil sands, Enbridge is proposing to expand its existing pipeline system to accommodate the growing demand for transportation service.

Alberta Clipper Pipeline Project

Alberta Clipper is a proposed new crude oil pipeline between Hardisty, Alberta and Superior, Wisconsin. The 914-millimetre (36-inch) pipeline will run 1,590 kilometres (1,000 miles) primarily within or adjacent to existing Enbridge right-of-way. Approximately 65 kilometres of new right-of-way will be required near Regina, Milden and Kipling, Saskatchewan and near Morden, Manitoba where the pipeline will deviate from Enbridge's existing right-of-way.

Alberta Clipper would have an initial capacity of 450,000 barrels-per-day, with the potential to expand to 800,000 barrels-per-day. Enbridge will file an application to the National Energy Board (NEB) in spring 2007. Construction is anticipated to begin in early 2008.

Southern Lights Pipeline Project

Southern Lights is a proposed pipeline which would transport diluent from the U.S. Midwest to the Alberta oil sands. A significant portion of the project involves reversing the flow of Enbridge's Line 13, which currently transports light synthetic crude oil from Edmonton, Alberta to Clearbrook, Minnesota. Once reversed, Line 13 would transport diluent received at Clearbrook to the Edmonton area.

To maintain and expand upon Enbridge's existing mainline capacity after conversion of Line 13, Southern Lights also involves the construction of a new 508-millimetre (20-inch) pipeline that would be constructed between Cromer and Clearbrook, and another existing southbound pipeline would receive pump modifications.

The completed Southern Lights diluent pipeline would have a capacity of 180,000 barrels-perday. Enbridge will file an application to the NEB in early 2007. Construction is anticipated to begin in early 2008.

Alberta Clipper and Southern Lights Open Houses

Open houses are scheduled in communities along the right-of-way to provide additional information about the two proposed projects. Please find the complete open house schedule enclosed as well as a route map for both projects and a NEB pipeline information brochure.

Enbridge is committed to engaging in meaningful consultation with you, your community and other interested stakeholders through open and transparent consultation. We welcome your input and questions regarding the projects.

A Proposed Pipeline or Power Line Project: what you need to know

ou have become aware of a pipeline or power line project that is proposed to be constructed in your area. The company planning the project may invite you to participate in a public consultation program for the project. This brochure describes:

- the role of the National Energy Board
- the Board's requirements regarding the company's consultation program
- Appropriate Dispute Resolution
- how you can get further information about the Board's processes

The Role of the National Energy Board

The Board is an independent federal agency that reports to Parliament through the Minister of Natural Resources Canada. The Board regulates interprovincial and international pipelines and power lines.

Before a company can commence construction of a proposed pipeline or power line, it must apply to the National Energy Board and receive the Board's approval. The Board decides whether the project is in the public interest and whether it should be approved.

For some proposed projects, the Board conducts public hearings in order to get all relevant views on the project before it makes a decision. The Board's decision about the need for a hearing depends on the nature of the project, its potential effects and the level of public interest in the project. Generally, a hearing is not required for projects that are less than 40 kilometres in length or for additions to existing systems.

Board hearings are open to the public and any person may attend the hearing as an observer. You may participate in a Board hearing by providing comments or becoming an intervenor. A person must apply to the Board to become an intervenor. Intervenors can be landowners, area residents, government agencies, Aboriginals, companies or any other individual or group that applies and is granted intervenor status by the Board.

The Company's Consultation Program

As part of the Board's application process, the company must meet the requirements of the National Energy Board Act, the Canadian Environmental Assessment Act, the Board's Filing Manual and other regulations or legislation. For most projects, the company is also required to conduct a consultation program.

The goal of consultation is to communicate with all individuals, groups and agencies that may be potentially affected by the project. The company should involve potentially affected persons early in the planning and design phases

of the project, should address public concerns and issues and should respond to any concerns or input provided by interested persons. The consultation program should be ongoing throughout the development of the project, the Board's regulatory processes and construction of the project. The Board also expects that companies will have plans for ongoing communication during the operation of the project. The Board encourages interested persons to become involved with the company's consultation program and to work with the company to address and resolve all issues and concerns.

The Board also expects the company to respond to any complaints it may receive from landowners or the public throughout the life of the project. The goal is for the company to address and resolve the concern or complaint as early as possible.

Appropriate Dispute Resolution

The Board's Appropriate Dispute Resolution (ADR) process is also available to you. An ADR process may help to resolve outstanding issues. ADR could take the form of a meeting between you and the company, which may be facilitated by trained Board staff or by another neutral third party.
